# Optimism buoys City of Laval's economic recovery plan City focuses on key industries and businesses in post-COVID-19 strategy

# Local unemployment rose from 4.1 per cent before COVID-19 to 14.2 per cent in May after the pandemic struck

With a high wind of optimism blowing through its sails, the City of Laval is moving ahead this week with a sweeping new economic development strategy designed to give a badly needed boost to the city's waning economy in the uncertain aftermath of the COVID-19 pandemic.

Dubbed 'Laval, capital of opportunities' by the Demers administration, the primary focus of the campaign is to provide support to entrepreneurs and business owners during the economically-challenged post-pandemic period.

### **COVID-19 fallout**

In a statement issued by the City of Laval prior to Demers' official presentation of the policy during the monthly city council meeting on Tuesday, city officials acknowledged that Laval has been as impacted by the fallout from COVID-19 as any other municipality in Quebec or around the world.

According to the city, six out of 10 businesses in Laval find themselves currently in "precarious" financial circumstances, ranging from moderate to severe, based on an evaluation conducted by E&B Data and numerical information provided by Statistics Canada for the Montreal Metropolitan Community (CMM).

### Non-residential tax affected

"This precariousness generates a significant risk, notably with regard to non-residential property tax," states an outline of the recovery strategy provided by the city. It further notes that Quebec is expected to be the most impacted province in the country, with a Gross Domestic Product falling by 8 per cent in 2020, compared to Ontario and Saskatchewan which are each expected to lose 7.5 per cent GDP.

More troubling, according to findings provided by the Institut de la statistique du Québec, is that unemployment in the City of Laval rose from 4.1 per cent - as measured this past

February when COVID-19 hadn't yet taken a hold in Canada - to 14.2 per cent in May when the pandemic was well underway.

### Facing the consequences

"The government had to put the economy on pause in order to slow the spread of the novel coronavirus while trying to avoid over-burdening the health system," Mayor Marc Demers says in the preface to a document outlining the recovery plan.

"With an equal amount of courage, we must now face the consequences of the confinement on our economic health. We are currently going through a crisis without precedent, with effects that are devastating on employment and the Gross Domestic Product of the whole region.

### A two-phase recovery

"Our corporate citizens, our workers and enterprises are terribly in need of support to get through this difficult period, while adapting to new realities and becoming confidently and audaciously part of the economy of tomorrow," adds Demers, noting that the new economic development strategy will be deployed by the city over the coming months and years.

The city is taking a two-phase approach to the recovery: first they want to stimulate Laval's economy to generate immediate results and wealth; and second they want to develop more sustainable projects which would become the basis for long-term economic progress.

Councillor Stéphane Boyer, vice-president of the City of Laval's executive-committee who is also responsible for economic development dossiers, suggests that significant support for businesses must be prioritized if there is to be an economic recovery.

### **Business a priority**

"The City of Laval is working relentlessly to provide aid directly to those most affected by the current situation," he said in a statement. "While new paradigms are emerging, such as social distancing, ecological transition, food and medical security and automation, we must take a second in-depth look at ways of thinking in order to seize all the opportunities when they become available."

According to the strategy outline, the Canadian and Quebec economies are only expected to begin improving sometime in 2021, with relaxation of confinement rules this year contributing to a rise in economic performance in the second half of 2020. But at the same time, it is expected that governments will gradually decrease their interventions.

### **Unemployment high**

The city's outline notes that the federal deficit, which stood at \$24.9 billion in 2019-2020, will stand at \$252.1 billion by fiscal year 2020-2021. As well, it points out that the fallout from unemployment will be even more severe than it was during the three most recent economic crises in 1981-82, 1990-92 and 2008-2009.

Between February and May this year, unemployment in Laval rose from 4.1 per cent to 14.2 per cent. The City of Laval recently revealed that it anticipates an eventual \$60 million post-COVID-19 deficit. Officials at the City of Laval's economic development department analyzed the municipality's commercial and industrial sectors and came up with a list of sectors where growth or economic shrinkage are predicted.

### Focusing on some sectors

On the positive side, computer software design, scientific research and food production and distribution emerge as areas where gains are already being made. However, retailing, tourism, entertainment and aerospace have lost a lot, although two of the three were on the decline already.

Other areas of Laval's industrial sector seen as potentially productive going forward include pharmaceuticals, plastics (used in face mask and shield manufacturing), as well as engineering and architecture.

The City of Laval says it is budgeting up to \$20 million for the recovery plan, only around \$6.3 million of which will come out of the city's own coffers. The remainder would come from federal and provincial programs and subsidies. The strategy would be deployed over a period of 18 to 24 months.

### City to use 'virtual currency'

A particularly fascinating aspect of the recovery plan is the city's decision to begin using a type of "virtual currency" – similar to Bitcoin and other emerging digital moneys – as a tool to promote local buying.

Whereas perks and points programs have been used in the past by credit card companies and retailers to encourage client support, a digital currency exists through computer "blockchain" technology, which allows them to operate independently from national currencies like the Canada or U.S. dollar or the EU Euro.

# I'M THINKING

# Media, Bias, and Politics

'Blame the media' is a frequent response to any problem of public image or perception, and it is certainly an element in discussing the present state of political engagement in Quebec. Relations between the media and politics, as institutions, have become increasingly poisonous in recent years, although it is important not to present too rosy a picture of how things used to be. Perhaps at one point between the servility of the 1950s and the cynicism of today there was an ideal situation, but it was a brief and unstable state of affairs.

The purpose of this piece is not to discuss the entirety of the relationship, but to make one or two points about how it affects the voters and public perception whether for federal/provincial elections, and, of course, the November school elections for the nine English school boards in Quebec under Bill 40. The discourse used in talking about politics is often baffling if not offensive to many citizens. It focuses on the aspect of politics which most voters, with good reason, care least about, particularly about school board elections where voter turnout is under 17%; who has won this or that argument, whose career is on the up, who is expected to do well or badly in this or that election.

Media coverage stresses the issues that matter to insiders, while often talking to the public in a mock-sophisticated tone of voice that purports to reveal the truth behind what the politicians say. Media presentation of politics and politicians (open to definition) is based to a large degree on a one-dimensional version of what motivates politicians and what they do. Yes, they do want power. Yes, they do use techniques to present things in the way most favorable to themselves. We know this. But they also represent different strands of public opinion, they have ideas and policies that may be good or bad for the country, province, city as a whole or for any given subsection of it. This is what often seems to be lost in political coverage. The press drives the news, rather than the news driving the press.

Journalists may choose not to cover a certain event such as the controversial legal challenge on the hearing of Bill 40 which took place at the Superior Court on June 26 under presiding Justice Sylvain Lussier. Because of lack of public interest in this matter, Gazette journalist stated to TLN that there would be no report on the event. Due to professional ethics, TLN chooses not to divulge the journalist's identity who was present at the hearing. TLN also contacted CJAD to inquire about the same subject, however, no response to date. Oddly, no talk show on this matter. We also attempted to call CBC, left a message, but no response; Global TV same song. Also called CTV, however,

the journalist who responded was not aware of the assignment, but assured that there will be coverage after the judge's decision on the injunction. Journalistic selection.

Furthermore, coverage of political social issues themselves reflects this bias towards conflict and narrative. They are seen through metaphors of battles, politicians and lobby groups lining up their ducks in every level with an ever increasing tendency to focus on insider strategy or the simple horse-race aspect of who is ahead. One cannot object to giving stakeholders information about how things stand locally, provincially, and nationally, but an obsessive focus on this alone denudes the process of meaning.

A step further than the understandable focus on the personal conflicts and ambitions inherent in politics is a deeply corrosive cynicism. This is something bordering on journalistic, let's say Fascism/Progressive Socialism/Marxism/ Anarchism, in which all elected politicians are contemptible, all judges are disreputable and only journalists are capable of telling the truth, even though what passes for truth is sometimes little more than prejudice unsupported by facts. There are large proportions of the electorate/ stakeholders who believe things which are demonstrably, factually untrue, or for which evidence is lacking.

It is entirely possible for media outlets to cover publicly contentious topics in an informative and responsible manner. Every situation is different, but I am increasingly hesitant producing an opinion piece when individuals wish to keep their anonymity because it is not my job to provide false balance and thereby justify bad journalism. When the evidence is clear-cut, the assumption that good journalism requires mutually opposed views to be treated as equally valid simply doesn't hold. False balance arises when journalists present opposing view-points as being more equal than the evidence allows.

Impartiality lies at the very heart of good journalism – avoiding bias is something on which respectable media outlets pride themselves. This is laudable, as robust debate is vital for a healthy media and, by extension, an informed society. But when the evidence for a position is virtually incontrovertible, it is profoundly mistaken to treat a conflicting view as equal and opposite by default.

None of this is intended to pin the blame for these deleterious consequences on journalists and media outlets alone. The assumption that good journalism requires mutually opposed views to be treated as equally valid simply doesn't hold when the overwhelming weight of evidence points resolutely in one direction.



# Opposition stirring in response to Île Gagnon development project Luxury condos and resort would be built at former home of Céline Dion

After several years of relative peace with its urban development dossiers, the City of Laval's administrators and elected officials are facing a possible public backlash over a developer's plans to convert a small island in the Rivière des Mille Îles - which was once the home of internationally-acclaimed singer Céline Dion – into a luxurious private resort.

### **Next to public park**

While it's not the first time a developer has set its sights on transforming the island, the task of turning Île Gagnon into an exclusive luxury destination is made all the more challenging by the fact it is located directly across a small inlet from the Parc de la Rivière-des-Mille-Îles, a public wildlife reserve where access is open

According to initial plans by property developer François Duplantie, 700 condos, a hotel, a spa, a gym and two restaurants would be built on Île Gagnon starting in 2022. A second phase of the project would take place later in nearby Sainte-Rose where development would include 970 apartments or condos, a retirement residence, a CHSLD and an entertainment

### **Opposition gathering**

Although the City of Laval is currently conducting a poll among residents of the area

to determine their support or opposition to the project, some members of the Laval city council opposition already are rejecting it outright.


While acknowledging that the project will bring in massive investment and help improve services in Sainte-Rose, independent city councillor for Saint-Bruno David De Cotis launched an opposing petition last week, while also demanding that the city hold a full public consultation.

In an interview this week with The Laval News, Mayor Marc Demers said nothing has been decided at this point, although the developer has yet to formally apply to the city for permission to begin his project.

### No commitment, says Demers

"We have insisted to the developer that he make a presentation on his own," said Demers. "There is no obligation on his part, although we wanted the presentation to be up to certain standards. And at one point residents of Sainte-Rose were even invited to take part. But there is nothing more we can do until the developer comes to us asking for construction permits."

Demers said the poll will help the city make a decision about the project. "Unfortunately, there is a lot of disinformation now taking place on social media," he said. "The course we decide to take will be guided by our surveys and by public opinion. But at this point there is no commitment on our part towards this developer one way or the other."

# **Racial profiling in Laval**

A little more than two weeks after holding Mayor Demers to account for a video that went viral showing an arrest made by two agents of the Service de Police de Laval (SPL), representatives of the Official Opposition, Claude Larochelle and Michel Trottier, welcome the concrete measures announced to stop racial profiling on the Laval territory. "It is crucial that citizens have confidence in the municipal government and its representatives," says the leader of the Official Opposition and Councillor for Marc-Aurèle-Fortin, Michel Trottier.

### Still a long way to go

Given the current context, the City of Laval is about to undertake essential steps in order to reinforce the confidence of the Laval residents in the Service de Police de Laval. This approach, which is intended to be a reaction to the latest events, is an unfortunate reminder that there is still room for improvement in social inclusion as well as visible and ethnic minorities representation in our society.

"As a municipal organization, I think it's healthy to have that kind of thinking and to



raise awareness on the matter. Now, we'll have to make sure we convert our words to action. I look forward to seeing the practical means that will be used to put into action the principles proposed today, in particular police officer recruitment procedures," said Mr. Trottier.

### investigation still pending

While the Official Opposition welcomes the various measures announced, the Councillor for Fabreville reiterated that an independent investigation is always necessary to shed light in the police intervention that occurred in Laval on

May 25: "If the City really wants to reinforce the principle of police accountability and improve its methods, this event must serve to help us progress! Not only must we evaluate in order to evolve, but we also need to be accountable to the residents who are questioning the events," added Claude Larochelle.

It is important to respect the parking signs and place your garbage and recycling bin on your property, so as not to interfere with maintenance on the public roadway.

Seasonal parking rules are in force throughout Laval territory, October 1 - April 30,

Monday - Friday, 8 a.m.

- 5 p.m., regardless of the weather .

During the day, residents will therefore have to make sure their vehicle is parked on the correct side of the street; however, during the evening, on week nights and on weekends, they will be able to park their vehicle on both sides of the street at all times (unless another parking restriction applies).

In its Policy on Parking, the City of Laval undertakes to eliminate alternate parking on all residential streets wide enough to permit it. In order to achieve this, Laval's municipal administration is implementing a pilot project that will see alternate parking prohibited, starting this winter, in three target zones

### **SNOW ON THE STREET**

Under Bylaw-L-10837 it is strictly prohibited to pile or deposit snow on a public road, whether on the street, on the sidewalk or on the median strips.

All offenders, whether the owner and / or the SNOW REMOVAL (BYLAW L-6070) person carrying out snow clearance operations, are liable to a fine.

### **TEMPORARY CAR SHELTER -BYLAW L-2000**



Temporary car shelter structures can be set up anytime on or after October 15.

The covering may be installed on or after November 1.

Car sherlters are allowed until April 15 of the following year.

However, the owner has to make sure that his temporary car shelter respects the prescribed standards by the zoning bylaws L-2000.

If the installation does not comply with the municipal regulation, Ville de Laval's Service de l'urbanisme could ask the owner to make the necessary modifications

Violations are subject to fines, according to the

The City of Laval would like to remind snow removal contractors, store owners as well as residents that it is strictly prohibited to pile up or deposit snow on a public roadway, whether on the street, sidewalk or on a median strip.

Furthermore, the contractor is responsible for any damage incurred to private or public property during snow clearance operations.

Offenders - whether the owner and/or the person carrying out snow clearance operations are liable to a fine

Notice to Snow Removal Contractors (Bylaw L-9975)

All snow removal contractors must obtain a registration at a cost of \$100 for the first vehicle and \$25 per additional vehicle, to indicate that they comply with the City's snow removal requirements, and place it on the upper right-hand corner of the windshield of each service vehicle.

The permits will be available starting mid-October.

It must be located at a minimum of 3.05 metres (10 feet) from all property lines and have a maximum height of 3.05 metres (10 feet) – Bylaw

### Advice

-Evaluate the location and general direction of the winds

- Install a fire screen.
- Use a metal container to remove the ashes.
- Install these appliances on a non-combustibles surface (concrete, gravel or grass) and not on a wooden surface.

### **CHIMNEY SWEEPING:** A MATTER OF SAFETY

It's important to have your chimney swept every

The purpose of this operation is to remove the accumulation of creosote or soot in the heating appliances in order to prevent chimney fires, which may jeopardize lives.

Every year, an inspection must be carried out on chimneys, the chimney flue and the connector

In addition, this must be done each time an appliance is connected as well as after each chimney fire, in order to detect any hazardous conditions

Ville de Laval recommends that you hire a chimney sweep recognized by the Association des professionnels du chauffage (APC).

### Look Out for Fraudulent

Companies Please note that no firm or professionals have been authorized by the City for chimney sweeping.

### **FENCES, RETAINING WALLS...**

(Bylaws L-2000 & L-9501)



Ville de Laval has established bylaws on fences. low walls, retaining walls and hedges in order to promote some visual harmony in residential areas.

The rules and regulations in this regard are designed to promote some visual harmony in the residential areas and mainly deal with the authorized location, materials and height; they concern the whole territory of Laval.

There are also additional restrictions for the district of Laval-sur-le-Lac and areas of heritage interest and if your home is located on land running along more than one street.

### **NUISANCES (BYLAW L-11465)**

Ville de Laval introduced a bylaw on nuisances in order to ensure a better quality environment and protect public health and safety.

This bylaw deals with overgrown grass, harmful weeds, odours, dust, smoke, light, wild animals, flyers and archery as well as with non-domestic and stray animals, and also deals with depositing or accumulating garbage, accumulating water, obstructing ditches and storing road vehicles .

Ville de Laval reminds its residents that open fires are prohibited.

### **RAGWEED - BYLAW L-5659**

It is up to owners, lessees or occupants of a vacant or partly built lot or land to destroy and eliminate any ragweed before August 1, namely before the flowers reach maturity.



Pulling it out is the most environmentally- friendly method to get rid of ragweed.

It is also possible to cut ragweed twice during the summer:

### 1.At the end of July

### 2.Before August 20

A conclusive eradication technique Since 2006, Ville de Laval has been using a ragweed eradication technique: Vaporization with saline water.

This process is used on some severely infested roadsides and has proven highly successful as all plants were eradicated with the first spraying.

Ragweed pollen affects over 30, 000 Laval residents every year.

The main symptoms of hay fever include sinus congestion, itchy and runny nose, itchy and watery eyes, and sneezing.

If allowed to grow and bloom, each ragweed plant can release millions of pollen grains, causing the allergic reactions associated with hay fever .

This is the reason why it is important to eliminate ragweed.

If you notice any ragweed in a field or vacant lot, please notify the City by dialing 311.

### **?** 311 or 450 978-8000 (from outside Laval) Don't Confuse Ragweed with Poison Ivy!

Ragweed and poison ivy are very different plants and must not be confused.

Unlike poison ivy, ragweed can be touched, and therefore pulled out, without causing skin rashes .

Garage sales placing various merchandise in public view to sell it elsewhere than at a public market or in a business establishment are authorized as








# Asymptomatic or presymptomatic? That is the question! Dr. Christos Karatzios\* clarifies the WHO's statement that caused a stir.

Through the great fortune we have of being able to have access to a specialized doctor like Dr. Karatzios we get the opportunity to ask all kind of questions and have an answer which helps dispel conspiracy theories, puts our minds at ease or informs us about when and how to be vigilant during this pandemic

A lot of people have asked Dr. Karatzios about what exactly the WHO UN meant when its lead Infectious Disease expert Dr. Maria Van Kerkhove said and tweeted that "spread of SARS-CoV-2 from asymptomatic people is very rare".

Dr. Karatzios was kind enough to clarify for us. According to him, the WHO UN didn't express itself properly and it is unfortunate. Already they had to backtrack on their perceived statement to clarify things.

It is unfortunate that they decided to differentiate between:

ASYMPTOMATIC people who carry the virus and never get sick – Yes, they won't spread it easily because they are not



coughing or sneezing and the amount of virus in their upper airways is low...and:

PRESYMPTOMATIC people who carry the virus but WILL get sick in the next few hours. They may have some scratchy throat and some mild congestion but not fever or other classic COVID-19 symptoms. Studies have shown that between 40-60% of the spread is from people who are about to get sick because they carry a large viral load in their upper respiratory airways and mouth even if they are not exhibiting (any or classic) symptoms yet.

Of course, once symptoms start, then spread continues until most symptoms resolve - most people will stop spreading infectious virus a week after they start being sick. Seriously ill and immune suppressed people may spread the virus longer. Clinical judgment is key because the nasal test can detect viral pieces for weeks in some people even after they finish their illness.

This definition of "asymptomatic and presymptomatic people" is RETROSPECTIVE. Doctors and people can't tell who will go on to get sick and who will never get sick. Doctors aren't fortune tellers and neither are people.

Therefore, social distancing, wearing masks when we can't socially distance and washing our hands are still key to stopping spread to others. Also, quarantining people who are known to be positive and their close contacts is equally important.

The WHO UN should be clearer when they explain things to avoid confusion and prompting Infectious disease experts, to offer explanations publicly for what the WHO un stated. So, looking forward... not retrospectively...asymptomatic people CAN transmit the virus.

Adding to Dr. Karatzio's assessment are a plethora of infectious disease experts like Dr. Faucci and Anne Rimoin, an epidemiology professor at UCLA's School of Public Health who gave us an idea of how asymptomatic carriers can spread the virus: "When you speak, sometimes you'll spit a little bit. You'll rub your nose. You'll touch your mouth. You'll rub your eyes. And then you'll touch other surfaces, and then you will be spreading virus if you are infected and shedding" the virus.





Online and phone-in activities

As Canada continues to get out of confinement and with recent news of cases, hospitalizations and deaths diminishing steadily, a lot of our fellow Canadians have begun to relax in terms of protecting themselves and others during the pandemic. Although it is encouraging to see the latest projections from health Canada, we have to remember that the virus has not been defeated.

SURGICAL MASK

Sam Laucks, a retired surgeon with 39 years

experience in the field of surgery describes the benefits of masks as our only protection apart from social distancing on his facebook page:

For a significant part of that time, I have worn a mask. I have worked with hundreds (probably thousands) of colleagues during those years, who have also worn masks. Not a single one us of became ill, passed out or died from lack of oxygen. Not a single one of us became ill, passed out or died from breathing too much carbon dioxide. Not a single one of us became ill, passed out or died from rebreathing a little of our own exhaled air. Let's begin here by putting those scare tactics to rest!

(It is true that some people, with advanced

lung diseases, may be so fragile that a mask could make their already-tenuous breathing more difficult. If your lungs are that bad, you probably shouldn't be going out in public at the present time anyway; the consequences if you are exposed to Covid-19 would likely be devastating.)

"But", you ask, "can't viruses go right through the mask, because they are so small?" ("Masks keep viruses out just as well as a chain link fence keeps mosquitoes out," some tell us.) It is true that individual virus particles can pass through the pores of a mask; however, viruses don't move on their own. They do not fly across the room like a mosquito, wiggle through your

mask like a worm, or fly up your nose like a gnat. The virus is essentially nothing more than a tiny blob of genetic material. Covid-19 travels in a CARRIER – the carrier is a fluid droplet-fluid droplets that you expel when you cough, sneeze, sing, laugh, talk or simply exhale. Most of your fluid droplets will be stopped from entering the air in the room if you are wearing a mask. Wearing a mask is a very efficient way to protect others if you are carrying the virus (even if you don't know that you are infected). In addition, if someone else's fluid droplets happen to land on your mask, many of them will not pass through. This gives the wearer some additional protec-

tion, too. But, the main reason to wear a mask is to PROTECT OTHERS. Even if you don't care about yourself, wear your mask to protect your neighbors, co-workers and friends!

### **Mask protection**

~ A mask is certainly not 100% protective. However, it appears that the severity of Covid-19 infection is at least partially "dose-dependent." In other words, the more virus particles that enter your body, the sicker you are likely to become. Why not decrease that volume if you can? "What have you got to lose?!"

~ "But doesn't a requirement or a request to wear a mask violate my constitutional rights?" You're also not allowed to go into the grocery store if you are not wearing pants. You can't yell "fire" in the Produce Department. You're not allowed to urinate on the floor in the Frozen Food Section. Do you object to those restrictions? Rules, established for the common good, are component of a civilized society.

"But aren't masks uncomfortable?" Some would say that underwear or shoes can be uncomfortable, but we still wear them. (Actually, being on a ventilator is pretty darned uncomfortable, too!) Are masks really so bad that you can't tolerate them, even if they will help keep others healthy?

~ "But won't people think I'm a snowflake or a wimp if I wear a mask?" I hope you have enough self-confidence to overcome that.

~ "But won't I look stupid if I wear a mask?" I've decided not to dignify that question with an answer!!

~ "But I never get sick; I'm not worried." Well, then, wear a mask for the sake of the rest of us

who are not so perfect!

There is good evidence that masks make a real difference in diminishing the transmission of Covid-19. Please, for the sake of others (and for the sake of yourself), wear your mask when in public. It won't kill you!

P.S. - And, by the way, please be sure that BOTH your nose and mouth are covered!

Recommendations around mask usage are confusing. The science isn't. Evidence shows that masks are extremely effective to slow the coronavirus and may be the best tool available right now to fight it.

They reflect graceful ageing, acknowledging how expectations and underlying beliefs directed and stimulated their lives.

On our visit to their home, social distancing in these pandemic times, we're warmly-received, no hugs. In conversation serious to sublime, funny in-between, the couple delved into private moments and poignant memories.

Their thinking is clear. "Mature but actively-involved people like us have always been interested in new forms of work, flexible creative lifestyles, supportive living arrangements. We valued work/life balance, choice, freedom and autonomy in decision-making," Irving asserts. They agree that boomers anticipated working and living longer, on their own terms, including fulfilling generational-care responsibilities. With clarity of purpose, the Applebees embrace their status as change agents.

### The journey

Their journey is lessons learned, milestones reached, testifying to how clear and powerful voices can help attain what's needed most in life. Irving who is bilingual, graduated from Verdun High, late 1950s, Evie from Northmount High, remains unilingual, thoughtful, knowledgeable. Arriving from England, school proved challenging for Irving. "He failed Math, yet he's known as the human calculator," says Evie, eyes twinkling. "When my dad died in 1962, I became the bread-winner, tried continuing my studies at McGill, but fate had other plans."

In pharmaceuticals for 52 years, Irving eventually retired on his own terms, to be with his wife. The only Jewish person at Crane Plumbing for 10 years, Evie recounts suggesting Christmas donation-drives for the elderly and people in need. Donations came from all over, delivered to many places. She became highly involved in volunteering and fundraising. Her voice, clear and confident, exhibits powerful tools of organization and total involvement in community/charitable organizations. "It's her life, always giving and helping, from age 18," Irving says proudly.

Evie's community involvement at Crane led to membership on boards of Mount Sinai (Cote St. Luc), and Cummings Jewish Centre for Seniors in Montreal. "Someone approached me to start Hadassah when I was volunteering at Cummings as cafeteria server. I loved interacting with people, became involved with everything in the Centre, the only one in North America run by volunteers, numbering over 1000." Irving was very supportive, joining her at Cummings.

### Daunted, daring, baring

The death of her mother and very close sister-in-law put things temporarily on hold for Evie. "Somehow, Hadassah reached me, we made a few phone calls, and from a gang of one (me), we blossomed. As founder 20 years ago and president since then, I've guided the Chapter through growth, and openness. Although a Jewish organization, it's open to everyone, including men. We're well-known here and beyond. One of many chapters worldwide, we're non-profit, raising funds for hospitals and projects in Montreal and Israel, where we support day centers, hotlines for abused

women, and children's health care. We're prominent in Laval/Montreal, close-knit in every way. Our members and supporters are very classy people."

When she came north from New York, after working in the music industry with the likes of Burt Bacharach, Dino Vale and Dionne Warwick, Evie thrived in modelling. It served her well, judging from recent pictures with Irving, posing in birthday suits (sort of), Mr. and Mrs. January in the Cummings Centre's 50th anniversary calendar. "When they asked, I went through the floor," says Evie. Irving didn't bat an eyelash. 'Do whatever you want, ok with me'. When the committee decided he should be in the photo too, 'No way in hell,' he said right away. But it was meant to be. Bingo! Irving, 72, was in. It was tasteful, good fun."

### Wedding bells, loss, care-giving

EVIE

-Where were you born? Where were you raised? I was born and raised in Montreal

- Have you lived anywhere else besides Chomedey, either as unmarried young people or as a couple?

As a married couple we always lived in Chomedey. As a single girl, I lived in New York for 3 years working for the music division (Famous Music) of Paramount Pictures. I worked for and with Burt Bacharach and artists such as Dino Vale, Diane Warwick.

- What were you doing before getting married? Before knowing each other?- Where, when, and why did you meet? I came in to Montreal (from New York) for a weekend to spend some time with family. It was in the summer and I was sitting on the balcony of my cousins house on de la Peltrie.

When I saw Irving drive by in his convertible, I asked my



cousin if he knew him. I told my cousin that "that's the guy I was going to marry." My cousin stopped him and introduced us. And that's where it all started.

- How long was your courtship? No joke ... 91/2 years

- Who proposed to whom? Where, When? Why?

Irving dropped me off at home one evening after a date and asked me for my ring size. I felt as though I went to heaven.

- Did your parents/families approve of your marriage? My parents loved Irving from the moment they met him.

- Evie, did you have one of those wonderfully traditional religious weddings or did Irving convince you to elope?

My father had planned a big wedding for us and then they decided to go to New York to buy us a wedding present. That's where our lives changed. My father had a heart attack in New York and passed away. Irving and I flew to New York immediately to be with my mother. It was a nightmare. Irving promised my mother that we would never leave her alone and he kept his word.

- Where were you married? When, if we may ask, but you don't have to answer?

Naturally we cancelled the big wedding that was planned. Irving cancelled the music, most of the guests and we held the wedding on the original date which was April 5th, 1970 at the Shaare Zedek synagogue.

### Honeymoon?

"Adventures in Mexico City and Acapulco. Clueless about voltage, wanted to iron an outfit, voltage blew, carpet and dress burnt. Acapulco, Holiday Inn, I was on the 18th floor, elevator blocked, hotel exploded, an electrical fire. Irving saved my life."

### When did you come to Chomedey?

"After our honeymoon, we moved into my parents' home to look after mom. We noticed changes, she had Alzheimer's. Mom lived with us 25 years before entering hospital. Irving was my pillar. We couldn't have done it without each other. We joined support groups to learn how to handle things."

Eventually, they ran an Alzheimer's self-help group for six years.

### **IRVING**

### -When did you take up residence in Chomedey?

Born in Cardiff Wales, Irving says he lived in Liverpool, England, in Verdun, Cote des Neiges.

Before getting married I was working and dating. Evie and I met 100 yards up the street from where I lived as I drove by to speak to her cousin. Our courtship lasted 10 years and I proposed to her in Dunn's on Ste. Catherine Street in 1969 because I loved her

"The moment I saw my Irving, I knew he would be the man I would marry," Evie adds. "That was my moment of perfect happiness. He's the love of my life. We're still on our honeymoon, have a great time together, we're still good friends, and we're partners in life. I was happiest the day I married Irving. But that day was bittersweet because I lost my father two months before we were married. And the birth of our two sons completed our happiness."

### **Evie's greatest achievement:**

"The Hadassah Chapter I formed this 20 years ago. We went from one person (me) to about 40 ladies today. Our girls are really nice and the best thing is we like each other. We have programming of lectures, presentations on a variety of topics - educational, social - and over the past few years have created a book club where our members do the reviewing.

# -What single act of injustice towards them affected the rest of their lives the most?

"Being bullied as a youngster, Jewish, and living in England during WW2," says Irving. "Grief, because we were extremely close with my brother. When my brother's late second wife would not allow both my husband and me to see him after having bypass surgery and eventually breaking up our family. This caused us much pain," Evie sadly responds.

### **Certain of their views**

### What do you consider the greatest human injustice?

For Evie, people not being treated equally, systematic racism in the police force, rejection of people's right to wear religious articles or headgear at work. I believe it should be left to individuals to wear what they want. For Irving, the treatment of all Black, Brown and Indigenous peoples.

What single act of kindness towards you affected the rest of your lives the most? Evie hesitates, "I can't think of a single act, but throughout my lifetime I have come across many people who have shown me special acts of kindness." Irving, pensively reflecting, "too many to think of any at the moment."

What do you consider the lowest depth of misery? When someone is in a very deep depression and doesn't know how to crawl out of that dark hole, Evie quickly answers. Irving adds "Depression (within one's self) Being Black, Brown or Indigenous."

# What is the best mark, trait or quality you consider most important in a man? "

He should have empathy, be caring, be a good listener, be trustworthy, intelligent and have a great sense of humour," Evie generously specifies. Irving, more succinct, proffers "Honesty" Evie states the same traits as a man for a woman.

### Changes, crises

# What changes has Chomedey's Jewish community lived through?

"Many moved to Montreal. Chomedey became multi-cultural, a variety of different religions and cultures, Greek neighbors, Indian, wonderful and interesting, especially when they share their delicious foods. The 60s exodus to Cote St. Luc was for convenience, the West Island for status, young entrepreneurs who could afford it. The kids take bigger risks than we would take. They're smart, aggressive, talented, and have better education than we did."

What originally attracted Jewish people to Chomedey? "Families came, late 50s," says Evie, "because they needed affordable homes. As more came, six synagogues were built."

# About the present U.S. Crisis, Covid-19, and racism in Canada, the couple agreed:

"People appear irrelevant to the government. Many Americans see Trump as irrational, think he doesn't care, others support him because he's a businessman, not a politician, they love the way he speaks. Covid hit America hard. There are huge differences in handling it. We have the same problem in Canada, especially Quebec where it's hit the hardest." Racism in Canada exists top-to-bottom including the RCMP, the police. "Live and let live, we all have something to contribute" says Irving, denouncing Bill 21 (banning religious symbols).

Evie, your work with Golda Meir Hadassah-WIZO is legendary. What keeps you going?

"I love what I do!"

### Your Golden Wedding Anniversary?

"We celebrated April 5<sup>th</sup>, Netflix, no family, no friends. COVID! We're just happy to be together, the most important daily gift. Some people have what they want; we have everything we need, each other."

### Love, happiness, dreams

Regrets?

"Not having travelled more," Evie bemoans. "Missing my father who was away after the war to support the family," Irving relates. *Talent you wish you had?* "Sing on key, play piano. I can only sing in key of Z, the only song, Happy Birthday." Evie jives. "To play a musical instrument," notes Irving.

### Current state of mind?

"Contented, at peace, beautiful flowers, birds singing, sun

shining. What more?" Evie asks. "Frustration over Covid-19, not being able to hug my son and his girlfriend," rues Irving.

### What would you change about yourself?

"Be more optimistic," Evie concedes. "To be more patient," Irving blurts.

### About family?

"For my son to marry his girlfriend," pleads Evie, with motherly love. "Bottle good things family has shown during Covid-19," *Your hero?* "My husband, best friend, fixer of things, makes breakfast, lunch and sometimes dinner. My go-to-person for advice, participates in my Hadassah group. We enjoy the same things,"

### Nothing ventured, nothing gained

Is there life after death?

Evie says "I'm very spiritual, studied and practiced spirituality for many years. I believe in the after-life," Irving counters a resounding "No."

### Motto you live by?

"Give and you will receive," from Evie, "Be honest," says Irving.

### Motto you wish everyone would live by?

"Respect everyone, be honest," the couple emphasizes. *Your bottle half-full or half-empty?* 

Both, depending on the day," Evie equivocates. "Half full," answers Irving, in certitude.

# Canadian seniors to receive one time tax-free payment

Seniors across Canada continue to face health, economic, and social challenges due to COVID-19. Many seniors are facing higher costs for food and services due to physical distancing restrictions, while others are paying more in dispensing fees to get the same medication or paying a premium for deliveries.

On Monday, the Honourable Deb Schulte, Minister of Seniors, highlighted that seniors eligible for the Old Age Security (OAS) pension, the Guaranteed Income Supplement (GIS), or Allowances will receive their one-time, tax-free payment this week without needing to apply. Seniors who reside in Canada can expect to receive the payment by direct deposit or cheque this week, whereas seniors who reside outside Canada can expect this one-time payment in July for those on direct deposit, or by cheque with delays given international postal disruptions.

Through several measures, the Government is providing about \$900 for low-income single seniors and more than \$1,500 for low-income senior couples, in addition to their existing benefits, to help with extra costs during the pandemic.

Seniors eligible for the OAS pension will receive a payment of \$300, and those seniors also eligible for the GIS will receive an additional \$200, for a total of \$500. Allowance recipients will also receive \$500. This \$2.5 billion investment in financial support will help Canadian seniors cover increased costs caused by COVID-19.

As we carefully and gradually re-open the economy, the Government of Canada will continue to support seniors and respond to COVID-19 health, social, and economic impacts.

### **Quick facts**

- •The large majority of OAS pensioners, nearly 85%, have after-tax income below \$50,000. Seniors receiving the GIS live on incomes below \$18,600 a year for singles and below \$24,576 a year for couples.
- •6.7 million seniors who are eligible for the OAS pension and 2.2 million who are eligible for the GIS will benefit from this payment.
- •The Government has taken a number of other actions to support seniors through the COVID-19 pandemic, such as:
- •Providing a one-time top-up payment through the GST credit in April. More than 4 million low- and middle-income seniors benefitted from this top-up, receiving a total of \$1.3 billion in financial support. Close to 85 per cent of single seniors and almost half of senior couples benefited from this payment.
- •Temporarily extending GIS and Allowance payments if seniors' 2019 income information has not been received. This will ensure that the most vulnerable seniors continue to receive their benefits when they need them the most. To avoid an interruption in benefits, seniors are encouraged to submit their 2019 income information as soon as possible and no later than by October 1, 2020.

- •Providing seniors flexibility with their Registered Retirement Income Funds, by reducing minimum withdrawal requirements by 25 per cent for 2020. This will help preserve assets during a volatile market.
- •Investing an additional \$20 million to expand the New Horizons for Seniors Program to support organizations that offer community-based projects that reduce social isolation, improve the quality of life of seniors, and help them maintain a social support network.
- •Contributing \$9 million through United Way Centraide Canada for local organizations to support practical services to Canadian seniors. These services include the delivery of groceries, medications, or other needed items, or personal outreach to assess individuals' needs and connect them to community supports.
- •Investing \$100 million to improve access to food for Canadians, including seniors, facing social, economic, and health impacts of the COVID-19 pandemic.
- •Creating a \$350 million Emergency Community Support Fund to support charities and non-profit organizations to adapt the services they provide to vulnerable groups, including seniors, in response to COVID-19.
- •Introducing the Canada Emergency Response Benefit (CERB), a taxable benefit of \$2,000 every 4 weeks for up to 24 weeks to eligible workers, including seniors, who have stopped working due to COVID-19. Pension income does not affect eligibility to the CERB.

### Bylaws- L-2000 and L-8554

Before installing your heat pump, your central air conditioning system or your wallmounted air conditioning units or even a swimming pool heater, inquire about the municipal bylaw aimed at promoting a certain visual harmony as well as peace and quiet in residential areas.

The regulations particularly concern the location of this equipment.

### **POOL AND SPAS**



Pools and Spas In Laval, there are very specific rules-and even stricter than provincial oneswith regard to the installation of spas as well as above-ground or in-ground pools.

Ville de Laval's bylaw stipulates the standards relating to pools, their accessories, the fence that must surround them, the fence gate and the documents you will need in order to obtain a certificate of authorization, which is required before installing a pool or spa (\$50) .

### A fence - it's a must!

An Enclosure Is A Must! Safety Access to all above-ground and in-ground pools or spas filled with over 45 cm (18 in.) of water must be protected by an enclosure (fence, railing and part of a building wall).

Enclosure specifications An enclosure must: tprevent a spherical object of 10 cm in diameter from passing through the at least 1.2 metres high thave no attachments, projections or openwork that could facilitate climbing the solid and rigid An enclosure may not consist of a hedge or shrubs. All gates to the enclosure must be equipped with a static security device installed on the inside of the enclosure, on the upper part of the gate, and allowing the gate to automatically close and lock after being opened.

In-ground: If you removed your in-ground pool and wish to receive a tax refund, please go to the Urban Planning Counter, located at 1333 boulevard Chomedey.

You will then be asked to fill out an application for a demolition permit, and pay a fee of \$25, and your assessment file will be adjusted accordingly.

### **SMOKE DETECTORS - (BYLAW L-9000)**



All properties must have a smoke detector (also called a smoke alarm) in working order.

In the case of a multi-family buildings, the landlord must install a smoke detector in each housing unit.

In a single-family home, each floor must have a smoke detector and the devices must be inter-

Advices: Make sure you verify, at least twice a year, if your alarm is working properly.

Furthermore, change the battery once a year or more if need be.

Fines: Any person who contravene any provision of these regulations commits an offense and is

### **WATERING- BYLAW L-4340 IN EFFECT MAY 15 TO SEPTEMBER 15**

Saving drinking water has long been at the heart of Ville de Laval's concern.

Aware of the importance of this precious resource that water truly is, Ville de Laval annually invests a lot of effort to preserve it.

Bylaw L-4340, which concerns the use and consumption of water, mainly aims to prevent wasting drinking water, and especially in the



summer

The City bylaw on drinking water consumption for outdoor use is in effect May 15 – September

Since last year, it is prohibited to clean parking areas and sidewalks with a hose; moreover, all new automatic watering systems must be equipped with a rain sensor

For buildings with an automatic watering system, watering is allowed 4:30 a.m. – 6 a.m.

every other day, depending on your address\*. For buildings with a non-automatic watering system, watering is allowed 8 p.m.

- midnight every other day, also depending on your address\*.

Watering by hand is allowed at all times, provided that it is done with a watering can.

Watering with a hand-held hose, equipped with an automatic water shut-off nozzle, is allowed at any time, every second day, depending on your address\*

A pressure washer may be used at any time .

New lawn To water a new lawn at prohibited times, you must get a lawn watering permit, which costs \$25 and is valid for 15 consecutive days.

This permit may be obtained at the Tax counter. Filling Pools Existing pools May 15 – September 15, you may fill and top up your pool every second day, depending on your address\*, regardless of the time of day

Newly installed pools May be filled at any time, regardless of your address, the day or the time Even-numbered addresses on even-numbered dates, and odd-numbered addresses on odd-numbered dates

### **TREE CODE - PROGRAM**



Bylaws L-2000, L-9501, L-10378 and L-10277 Ville de Laval's city council has adopted, during a special assembly held on June 19, 2002, a bylaw promoting tree planting and tree maintenance.

Laval residents are therefore eligible to a financial assistance when they plant or keep a tree in

Ville de Laval's Tree Code includes specific guidelines that everyone must follow, and particularly with regard to the types of eligible streets or to the location of trees.

And don't forget that homeowners must obtain a certificate of authorization before cutting down

### **CHILD CARE - BYLAW L-11015**



The purpose of this bylaw is to ensure safety and security, well-being and sanitation in private child care on Ville de Laval territory and not coming under the jurisdiction of any other authority .

More specifically, this bylaw is aimed at all child care services from birth to eligibility for pre-school education, including nursery school, drop-in daycare centres and home child care services not recognized by a coordinator's office, that accommodate a maximum of 6 children (with a maximum of 2 infants), including those of the owner who are under 9 years of age and who are on hand .

### Steps

All owners who operate such a service must obtain an operating licence from Ville de Laval .

To obtain this licence, you must first obtain an occupancy certificate delivered by the Service de l'urbanisme and available at the Urban Planning Counter

**OPERATING LICENCE** Procedures A license is mandatory prior to being authorized to operate a child care facility .

Documents required when requesting a permit:

•Curriculum vitae

•Submit an example of a one-week menu consistent with Canada's Food Guide

•Provide two reference letters signed and dated, including the contact information of the persons signing the letter (phone number and address)

•An example of the registration form (to register a child for care services)

•A document outlining the operations of the child care service (cost, holidays, bylaws of the child care service, cancellation form)

•An example of an authorization form to administer medication and acetaminophen, apply lotion, administer nasal drops, apply sunscreen, and authorize outings and swimming activities.

•Copy of the registration with the Registre des entreprises individuelles ou des sociétés •An example of a typical day and an annual activities program .

•Apply for an occupancy permit and make a cheque payable to Ville de Laval •Apply for an Attestation establishing that no impediment exists (valid for 3 years) .You will need to submit two pieces of identification, namely one with a photo and one with proof of residence .In addition, you will need to submit a citizenship card (if applicable)

### **Essential inspections**

- •• An inspector from Ville de Laval's Service de sécurité incendie will come to make sure that the general fire safety requirements are being met;
- •• A representative from Ville de Laval's Service de l'urbanisme will come and look after enforcement of the regulations on zoning and construction:

### FOSTER CARE FOR ADULT (BYLAW L-11015)

The purpose of these rules and regulations is to ensure safety and security, well-being and sanitation in private foster care services for adults on Ville de Laval territory and not coming under the jurisdiction of any other authority.

More specifically, this bylaw is aimed at all private foster care services for 3 adults (or seniors) or more, on a full-time basis, whether temporary or permanent .

All owners who operate such a service must obtain an operating licence from Ville de Laval .

This licence is free of charge and is renewable every year.

### What Lies Beneath

About six weeks ago, I broke up with my boyfriend of three years. I am still struggling to find the truth.

There were several incidents which led me to believe he cheated on me, but he refuses to admit to anything. Two of the most obvious incidents were women telling me from their own mouth that they slept with him. These were isolated incidents about six months apart.

He says they are both lying, even though the first woman told me this early in our relationship. We are now not together, but I still want the truth from him. It eats at me every single day.

Recently we started seeing each other again. I know I shouldn't, but I still care about him and it's better, or so it seems, than the uncertain future of being single again. Why will he not tell me the truth? Is there any possibility he actually is telling the truth?

How do I move on?

Ginger, you want to leave the door open by claiming you can't move on until you have the truth. But you don't want the truth. You wanted an extremely plausible lie, and you will search high and low until you find it.

You had three years to gauge what this man is like. Three years to record what his voice, manner, and posture tell you. Then your gut reported, "Yep, he's lying." *In addition, you have testimony from two* eyewitnesses and incidents you allude to without mentioning. In the law that's called a preponderance of evidence.

Still, you hold out for a confession, even though most criminals are convicted without a confession and most guilty people never confess.

In the movie A Few Good Men, Tom Cruise, as a Navy lawyer, relentlessly interrogates Jack Nicholson, a Marine colonel. Nicholson avoids answering the questions until finally, exasperated, he



blurts out, "You can't handle the truth!" That's the problem. You can't handle the truth. It is too disconcerting. Even if he confessed, your mind would create another line of defense, such as, he promised to change.

This man has nothing to gain from telling the truth, but he does have something to lose. You. So the battle is not with him. The battle is in your interior world, a place where you cannot handle the truth.

You stayed with a man who cheated on you because of a weakness within you. That weakness, that foible in you, is the part that made up "I can't let go until I get the truth."

That's not love. It's the part in you which needs fixing. And a big part of what needs fixing is what his cheating did to you. It has lowered your confidence and your self-esteem. It has made you feel you cannot attract a good man. It has made you feel you don't deserve better.

It's a chicken and egg problem. He made you feel like no one else will want you, and now you act as if he is the only man in the world. But there are plenty of other men out there, and you have decades of life ahead of you.

When people write us, they almost always tell the truth, though they can't see it themselves. "I am staying because I don't think anyone else will want me." That's the truth you told us.

Your letter is about fear, and there is only one truth about fear. Living with fear is worse than facing fear. You've named your fear. Now face it

# COVID-19 death toll reaches 100 at CHSLD Sainte-Dorothée

A new milestone was reached in Quebec last week during the ongoing COVID-19 pandemic.

Provincial health authorities revealed that CHSLD Sainte-Dorothée in western Laval had reached 100 fatalities, making it the province's public long-term care residence that has been most impacted by COVID-19 since the beginning of the pandemic more than four months

With a capacity for 285 residents, the news means that more than a third of the residents of CHSLD Sainte-Dorothée succumbed to COVID-19. The latest fatality count was published in a province-wide update of the COVID-19 toll issued by the Quebec Ministry of Health and Social Services on July 2.

Two other CHSLDs in Laval made the list, although with slightly more moderate numbers.

CHSLD Sainte-Jude on Saint-Martin Blvd. had recorded 71 fatalities up to July 1.

However, it wasn't all bad news. CHSLD Idola-Saint-Jean on Cartier Blvd. in Laval des Rapides has had only three fatalities since the start of the pandemic.

CHSLD Sainte-Dorothée's record is only slightly greater than the number of COVID-19 fatalities reached at two Montreal CHSLDs. The Centre d'Hébergement Notre-Dame-de-la-Merci on Gouin Blvd. has had 94 deaths, while CHSLD Laurendeau also on Gouin Blvd. has had 92 fatalities.

According to the figures released by the provincial health ministry, a total of 968 people have died in Quebec's CHSLDs since the beginning of the pandemic.

# Yet more hand sanitizer warnings

Health Canada has issued yet another advisory to Canadians regarding hand sanitizers that may pose health risks.

The warning comes following previous notices issued by the federal agency on other hand sanitizer products.

The latest advisory concerns hand sanitizers made with industrial-grade ethanol, which is not authorized for use in hand sanitizers and may pose health risks.

This is the latest list of hand sanitizers on Health Canada's watch.

# Man arrested in Laval for Toronto-area 'distraction thefts'



Police in the Greater Toronto Area say that following a jointforces fraud investigation of alleged "distraction thefts," they have two suspects in custody – one of whom was arrested in Laval.

The Toronto Police Service says that, between March 8 and June 11, Constantin Liteanu, 46, of Burlington ON, and Laurentiu Avram, 35, of Vaughan ON, were involved in a series of distraction thefts in the Toronto, Peel, Halton, Guelph, Niagara, Durham and Barrie regions. The police say Avram was arrested in Laval.

According to the allegations, the two men would approach other drivers while out on the road and claim they were having car trouble. While one would distract the victim, the other would steal debit and credit cards in the targeted vehicle. The cards would then be used fraudulently to make bank withdrawals and purchases.

Avram was scheduled to be arraigned later this week. The charges against him include:

Laval Police arrest suspect following Chomedey/Notre Dame hit-and-run



Up to four Laval Police Department cars and at least one Urgences Santé ambulance converged in the parking lot of the Centre Commercial Saint-Martin near the corner of Curé Labelle and Notre Dame boulevards around 9:45 am on Tuesday June 30 shortly after a hit-and-run incident a few blocks east at the corner of Chomedey and Notre Dame.

Although the driver of one of the three vehicles involved in the crash fled the scene, he was found by the police shortly afterwards just a few blocks west where his car was surrounded by police.

While the suspect driver was placed under arrest, he and a passenger were transported by Urgences Santé to hospital where they were treated for minor and non-life-threatening injuries, said Constable Julie Marois, a spokesperson for the LPD.

"In all, three vehicles were involved," Cst. Marois told *The Laval News*. "We learned that one of the vehicles had fled the scene. With a description of the suspect who had fled, our officers proceeded to make the arrest of this individual."

### Water patrols will be active throughout the summer



Laval is a city that is surrounded by two major bodies of water: one one side is the Rivière des Prairies, while on the other is the Rivière des Mille Îles.

In order to ensure the security of pleasure boating enthusiasts, a water patrol from the Laval Police Department will be present in the waters surrounding Laval from June to September.

### **Patrols on duty**

In addition to responding to distress calls, the patrollers carry out prevention and surveillance operations throughout the summer. With the return of the warm period, there will be many pleasure boaters on the waters.

The LPD would nonetheless like to remind all boaters that the rivers around Laval can be tricky and caution is required. For

example, in some places there are narrow channels where water levels are shallow and temperatures can become guite cold.

### **Rules to follow**

For this and other reasons, boat drivers should always be respectful and courteous and follow all applicable rules on the water. It is recommended they also follow water safety guidelines. Here are some of the guidelines:

Never drink before driving a boat; always have safety gear on board, including a sufficient number of flotation vests; always follow the rules of navigation; be respectful towards waterfront property owners by reducing speed when passing by and turning down your on-board music.







# Going back to the movies?

Some new rules to follow in the COVID-19 era



(TLN) Four months after being forced to close because of the COVID-19 pandemic, the province's movie theatres are reopening – albeit with new rules that limit the number of viewers to 50 per screening room in multiplex cinemas for the time being.

It's no secret that the COVID-19 pandemic forced the shutdown of a good number of major film productions since the beginning of the year. As such, the selection of movies in theatres is expected to be much slimmer than it would normally be at this time of year.

However, some films whose screenings were interrupted earlier this year will resume, while some theatre chains say they will be prioritizing family-fare in their selection of movies in order to accommodate those who've been locked down and in need of wholesome entertainment. during the upcoming recovery period.

"I prioritize films for the whole family because that's what always works best during the summer," says Vincent Guzzo, president of the Cinémas Guzzo film theatre chain. "We will also be bring back on the screen comedies and action films which were doing well before the lockdown."

Here are some of the rules and protocols that movie-goers will be asked to follow when they start turning up once again at movie theatres across the province.

After tickets have been purchased, an attendant attired in protective gear will greet you at the theatre's main entrance where you will be required to disinfect your hands. All attendants will be wearing protective face masks and

visors. They will also have to regularly disinfect their hands and carry out regular sanitation of contact surfaces throughout the theatres.

Theatre patrons will be required to follow safety protocols, which include maintaining a two-metre distance with other people in common areas. While the wearing of face masks in public places hasn't yet been made mandatory by the provincial government, at least one Montreal-area theatre chain plans to sell face masks at its multiplex theatres for clients who would feel safer that way.

As far as the food and snack concessions go, little is changing. The only rule that will apply in lineups will be the six-metre distancing requirement. Two-metre space markers are being made on the floor in front of snack concession areas to make it easier.

While movie customers will generally be required to sit while observing the two-metre distancing requirement, theatre owners are being allowed to seat small groups of people together as long as they are members of the same family residing in the same household. While the maximum number of people allowed into a screening room is 50 for now, it could increase to 250 by mid-July depending on the COVID-19 situation.

Screening rooms will be thoroughly cleaned and disinfected following each film screening. Customers will also be asked to their part by not leaving behind too much trash, thus making the cleanup job a little easier and safer for employees.






